The Board is in favor to establish requirements and rules for endorsement candidates that assures competency without adding unnecessary barriers. This includes:

- Accepting first credential evaluations as long as it was prepared using the course work tools (CWT)
- Establishing a certain amount of clinical practice hours
- Written statement from applicant's most recent employer
- Good standing in state applicant is endorsing their license from

Ms. Shah summarized the case for the Board. Respondent was charged with the following violations: **Count I:** Section 486.125(1)(a), Florida Statutes (2011) by being diagnosed with alcohol dependency, failing to comply with PRN recommendations, and being deemed unsafe to practice physical therapy by a Department-approved evaluator, who is a specialist in addiction medicine. **Count II:** Section 486.125(1)(k), and 486.125(1)(c), Florida Statutes (2011) by entering a plea to crimes which relate to the practice of physical therapy, or the ability to practice physical therapy, by entering a plea of nolo contendere, and resisting an officer with violence, on October 17, 2011, in St. Lucie County, Florida. **Count III:** Section 486.125(1)(k), and 456.072(1)(x), Florida Statutes (2011) by failing to report in writing to the Board of Physical Therapy office that she entered a plea of nolo contendere to the charges of DUI, battery on a law enforcement office, and resisting an officer with violence, on October 17, 2011, in St. Lucie County, Florida.

The case was presented as a Settlement Agreement that would impose the following:

- Reprimand
- Reimbursement of Costs in the amount of \$1,682.36 to be paid within 2 years of the Final Order date.
- Indefinite suspension from practice until she complies with PRN and PRN determines that Respondent is safe to practice. If a contract is appropriate, the Respondent will be required to execute such a contract prior to having the suspension lifted.

Dr. Martha Brown, Assisted Medical Director with PRN, was present to address the Board.

**MOTION:** After discussion, Dr. Petraglia made a motion to accept the Settlement Agreement. The motion was seconded by Ms. Acuna-Parker and tied 2/2. Dr. Hellman and Mr. Rust opposed.

Mr. Burleson was not present nor represented by legal counsel.

Ms. Shah summarized the case for the Board. Respondent was charged with the following violations: **Count I:** Section 486.125(1)(b), 486.125(1)(k), 456.072(1)(h), and 456.072(1)(m) Florida Statutes (2005-2007) by obtaining a physical therapist license by fraudulent misrepresentation or by an error of the department or the Board when the Respondent answered "no" to the criminal history question on each application and/or failed to update applications when the applications were pending before the Department,

when Respondent knew prior to submitting the applications for licensure and/or while the applications were pending for licensure that he had entered a plea of nolo contendere on December 6, 2005, to driving under the influence in Duval County, Florida. **Count II:** Section 486.125(1)(k), and 456.072(1)(z), Florida Statutes (2005-2007) by failing to notify the Board and Department of his pleas of nolo contendere to driving under the influence on December 6, 2005, and domestic battery on May 23, 2008, in Duval County, Florida.

The case was presented as a Settlement Agreement that would impose the following:

- Reprimand
- Fine of \$1500.00 to be paid within 365 days of the Final Order date.
- Reimbursement of Costs in the amount of \$618.65 to be paid within 365 days of the Final Order date.
- Within 60 days of the Final Order date, apply and register for the Laws and Rules exam, and pass within 1 year.

**MOTION:** After discussion, Mr. Lohr made a motion to reject the Settlement Agreement. The motion was seconded by Ms. Acuna-Parker and carried 4/0.
